NOTE:- 1. Selection of above candidate is subject to the biometric and Socio-economic marks verification and other qualification by the department, biometric/facial verification of any candidate fails during joining or at any other stage or if candidate is found taken fake/false benefit of Socio-economic criteria, then he/she will be ousted from the selection list and candidature may also be cancelled. Candidate is intimated to produce & submit certificate issued by Tehsildar/Executive Magistrate/SDM regarding 'No Govt. job in family' under socio-economic criteria at the time of joining to department.

2. As per Govt. Instruction no 22/10/2010-1GS III Dated: 23.05.2014,if suitable candidates of Ex-Servicemen are not available in a particular category, then the vacancies be filled up from amongst the same category candidates.

3. As per Govt. Instruction no 22/10/2019-1GS III Dated: 25.02.2019,if suitable candidates of EWS are not available , then the vacancies be filled up from unreserved category candidates.
