Incontinuation of earlier notice dated 07.01.2019 and 13.12.2021 and On the basis of Written Examination, re-scrutiny of Documents and interview/Viva-Voce for the post of PGT Commerce (ROH) of Education Department, Haryana against Advt. No. 04/2015, Category No.03, the Commission has finalised the result in compliance of orders dated 01.09.2021 passed by the Hon'ble Supreme Court of India in SLP nos.25184-25214 of 2018-Haryana Staff Selection Commission Vs. Priyanka & ors.

Chief Secretary to Government of Haryana vide Memo No. 22/149/2015-1 GS-III dated 5th March, 2019, has informed that the State Government has decided that in respect of all advertisements where result of SBC has been put on hold due to Court Orders, the Haryana Staff Selection Commission shall treat the SBC posts to be under the Unreserved/General Category.

Therefore now, in continuation of earlier notice dated 07.01.2019 and 13.12.2021 and on the basis of Scrutiny of Documents and Interview Viva-Voce, for the posts of PGT Commerce (Rest of Haryana), Cat. No. 03, Advt. No.04/2015 of School Education Department Haryana, Commission has finalized and declared the result. The result has been shown roll No. wise and category wise. The marks secured by the last selected candidate in each category have been shown in brackets.
